

SDSU Spring 2016 Fee Payment - (as of 11/04/2015)

The following fees are applicable for the Spring 2016 semester only. The CSU makes every effort to keep student costs to a minimum. Fees listed in published schedules or student accounts may need to be increased when public funding is inadequate. Therefore, CSU must reserve the right, even after initial fee payments are made, to increase or modify any listed fees, without notice, until the date when instruction for a particular semester or quarter has begun. All CSU listed fees should be regarded as **estimates** that are subject to change upon approval by the Board of Trustees. Changes in mandatory system wide fees will be made in accordance with the requirements of the Working Families Student Fee Transparency and Accountability Act (Sections 66028 – 66028.6 of the Education Code). Students will be liable for amounts as a result of such changes.

Student Involvement Representative Fee (SIRF)

The CSU Board of Trustees adopted the SIRF, establishing a stable model for the California State Student Association (CSSA). The new funding model expands independence and builds capacity to engage students in advocacy and policy making. The funding model consist of a \$2.00 per-term fee assessed to each CSU student, on a voluntary basis, allowing the choice to opt-out each semester.

In addition to Basic Tuition and Fees, Non-Resident and Graduate Business Professional students are required to pay a per unit fee (listed below).

Non-Resident (Foreign and Out-Of-State) Tuition

In addition to Basic Tuition and Fees a per unit fee is charged for all units attempted \$372.00 per unit

Professional Program Fee

In addition to Basic Tuition and Fees and *(if applicable)* \$254.00 per unit
 Non-Resident Tuition a per unit fee is required for courses taken in fee authorized state-supported professional business graduate program

Basic Tuition and Fee Installment Plan

Installment payments can only be submitted **On-Line**. A payment of \$800.00 for Basic Tuition and Fees must be submitted in addition to the \$60.00 Installment Plan Service Charge. (For a total of \$860.00)
